Launching two new programs

The Community Foundation of Grundy County launched two new initiatives in 2014: "Non-Profit Tools for Success" and a Senior Network.

"Tools for Success" (TfS) is a monthly after-hours for not-for-profits to network and hear a presentation on a topic relevant to the administration of a quality not-for-profit. All not-for-profits serving Grundy County are invited to attend, whether a social service agency, church, government office, youth sports, fine arts, etc.

The concept and implementation of TfS is fairly simple – gather colleagues, feed them, ask those colleagues for topics they want to learn about, and ask an expert from the area to come present.

We kicked it off in June with Christina Chapman Van Yperen of the Morris Daily Herald who gave us some very direct tips for how to submit press releases that get noticed and published – tips that are very different from the way it has been done in years past. Two quick tips: 1) Always email your story so that staff can simply cut and paste (no one re-types from fax anymore) and 2) The cameras on cell phones are not quality enough to print larger in the paper, so always use a real camera – then email the photo. Needless to say, her presentation got rave reviews!!

July was a holiday month. August was a presentation by Jay Fillman of the Foundation board about non-profit financials. September was Lea Ann Skogsberg presenting tips for writing grant proposals. Caroline Portlock presented non-profit HR (human resources) tips in October. David Terrill presented planned giving basics in November. December focused on board governance with Katheryn Wiedman. January was postponed due to weather, but Eric Peterson returned in February to lead a conversation about free and low-cost software and technology.

Why host and coordinate this program? The Community Foundation of Grundy County improves the quality of life

in Grundy County through leadership and philanthropy. Not-for-profit agencies and organizations are a large part of our community, therefore improving their capacity to be the best they can be improves the quality of life in our county.

Our second initiative to launch in 2014 is the Senior Network, which is a meeting of the minds of the agencies and organizations who serve our county's retirees.

We kicked it off with a big event in October with guest speakers Lucia Jones of the Northeastern Illinois Agency on Aging and also Professor Lisa Hollis-Sawyer in the gerontology program at Northeastern Illinois University. Both women did an outstanding job of talking about the services and amenities that are available (and should be available) in a community to make that community appealing and functional for senior citizens.

Since then, we have convened the group of service providers on a bi-monthly basis under the leadership of Devan Gagliardo, the Foundation's Program Director.

As the network has assessed the services, needs, and gaps in Grundy County, two needs rise to the top: 1) The desire for more recreation and social interaction for seniors and 2) communications.

There is an acknowledgement that sometimes it isn't a lack of recreation and activities for seniors – it is sometimes lack of transportation or the time of the recreation and therefore transportation can be a problem. For example, many seniors have difficulty driving after dark. This is an even more frustrating problem in winter as it gets dark so early. Even those drivers who are willing to carpool and pick up friends get nervous about being responsible for the safety of a carload of friends.

So what is being done to solve this issue? So far we can report that we are working with the City of Morris to

expand the services of the city PUP van. How can we use our grantmaking to expand transportation for seniors? Stay tuned for details!

The second issue to come out of the Network is communications – What's happening and how do seniors find out?

This is our appeal to service providers: If you provide ANY service or entertainment that seniors can attend, PLEASE use the media outlets available to you. This includes the Morris Daily Herald, the Coal City Courant, The Paper in Dwight, the Herald LIFE in Minooka and Channahon, WCJS-WJDK, the Grundy Chamber of Commerce, and the Grundy County Interagency Council. You can also include the villages, churches, libraries, and schools in your distribution list. Please send your information 5-6 weeks in advance and use the "Tools for Success" tips on the Foundation's website. AND be sure to update your website, Facebook, and Twitter regularly – at least weekly!

Our appeal to Grundy County's seniors: Pay attention to what's out there – there's a lot! Communication is a two-way street and you have to seek out information. Read the papers, listen to the radio, and look at websites and Facebook. Getting on the internet may be intimidating for some, but we beg you to try, and there are great resources to help you. The libraries and the Grundy County Housing Authority have all hosted events in the past to help seniors get online. Does your family often wonder what to buy you for gifts? Tablets and internet subscriptions make great gifts!!

We are proud to have launched both "Tools for Success" and the Senior Network. Both are moving along well and doing great work. President's Commitment

REFLECTING ON 2014 WITH THE COMMUNITY FOUNDATION

As I reflect on the numerous successes and opportunities the Community Foundation of Grundy County has had in 2014, I have to start with the fundraising following the devastating tornado in Diamond and Coal City in November 2013. Our Foundation, along with Operation St. Nick, We Care and United Way raised a total of \$415 thousand, all of which was paid out to the affected residents and businesses within the tornado damaged area. It was an amazing act of generosity from Grundy County and around the nation. The Community Foundation and Operation St. Nick have since started a permanent Disaster Fund, so we are even better prepared to help our residents whenever disaster strikes.

On a calmer note, the Community Foundation has started a new program this year for the other not-for-profits in the county - Tools For Success. This is a monthly 5pm meeting where a subject of interest has a speaker present the topic, whether it involves finances, board governance, or organization transparency. This has been very well received, and will continue in 2015.

The Community Foundation has grown from assets of \$50,000 to \$6,000,000 in the past ten years. Since 2003 we have granted out over \$1,000,000. Through the power of our endowments, we have made life simpler when we can count on the 4% withdrawal from the endowment every year.

This past year we have negotiated and recently purchased the old We Care condo at the Canal Port Community Center. We did this without spending Foundation money, thanks to the generous donations from the Board of Trustees. We will be remodeling the property this Spring, and hope to be moving in by early Summer.

And lastly, the Community Foundation of Grundy County was recently named the 2014 Organization of the Year by the Grundy County Chamber of Commerce. We are deeply honored by this recognition.
